- This number does not include 2,688,212 shares of common stock underlying outstanding options held by Mr. Crouch; post-transaction Mr. Crouch continues to beneficially own or have a right to acquire 2,836,972 shares of common stock.
- The option shares vest and become exercisable over 16 equal quarterly installments measured from May 15, 2018.
