- This number does not include 1,582,192 shares of common stock underlying outstanding options held by Dr. Presnell; post-transaction Dr. Presnell beneficially owns or has a right to acquire 1,926,040 shares of common stock.
- The option shares vest and become exercisable over 16 equal quarterly installments measured from May 15, 2018.
